Retail Pioneer Piggly Wiggly® Founded By Clarence Saunders in Memphis, 1916

Ann Boone Call of Bartlesville, Okla., asked me if I was working on a story about Clarence Saunders, the founder of the Piggly Wiggle Stores. I had never heard that, but I managed to find the web site for Piggly Wiggly which gave the following information. (See page three for additional information concerning this Clarence Saunders and possible relations.)

Where It Began...

Piggly Wiggly®, America's first true self-service grocery store, was founded in Memphis, Tennessee in 1916 by Clarence Saunders. In grocery stores of that time, shoppers presented their orders to clerks who gathered the goods from the store shelves. Saunders, a flamboyant and innovative man, noticed this method resulted in wasted time and man hours, so he came up with an unheard-of solution that would revolutionize the entire grocery industry: he developed a way for shoppers to serve themselves.

Despite predictions that this new kind of store would fail, the first Piggly Wiggly opened September 6, 1916 at 79 Jefferson Street in Memphis. Operating under the unusual name Piggly Wiggly, it was unlike any other grocery store of that time. Shopping baskets, open shelves, no clerks to shop for the customer — unheard of!

Piggly Wiggly Corporation, established by Saunders when he opened the first store in Memphis, secured the self-service format and issued franchises to hundreds of grocery retailers for the operation of Piggly Wiggly stores. The original Piggly Wiggly Corporation became owner of all Piggly Wiggly properties: the name, the patents, etc., and Saunders began issuing stock in the Corporation. This stock was successfully traded on the New York Stock Exchange for some time, but through a series of stock transactions in the early

'20s, Saunders lost control of Piggly Wiggly and had no further association with the company.

Piggly Wiggly Corporation continued to prosper as franchiser for the hundreds of independently owned grocery stores franchised to operate under the Piggly Wiggly name and over the next several decades, functioned successfully under various owners.

All in a Name

Saunders' reason for choosing the intriguing name Piggly Wiggly® remains a mystery; he was curiously reluctant to explain its origin. One story is that he saw from a train window several little pigs struggling to get under a fence, and the rhyming name occurred to him then. Someone once asked him why he had chosen such an unusual name for his organization, and Saunders' reply was, "So people will ask that very question." He wanted and found a name that would be talked about and remembered.

Piggly Wiggly's introduction of self-service grocery shopping truly revolutionized the grocery industry. In fact, many of the conveniences and services that American shoppers now enjoy were introduced first by Piggly Wiggly®.

Information About Pastor Robert W. Sanders, Author of Book, *Sanders Family History*

[The following, taken from pp 37-38 of the *Sanders Family History*, gives biographical information about the author, Robert W. Sanders. He was the youngest son of William Seaborn Sanders, who was one of the seven sons of William Sanders, brother of Moses, Sr. This book was found in the public library of Kingsport, Tennessee.]

(j) - Robert Wilson Sanders, youngest son, was born Sept. 12, 1847. Of him the writer should not speak except for the consideration that our story would not be complete without some reference to him. The attempt will be made to limit what is said to simple facts, humbly recorded.

Robert, while a small boy, worked upon the farm and about the home and premises. He began to plow when eight years old, served seven summers in this way, going to school parts of the time. In 1863 and 1864, he went regularly to school, going through English grammar and arithmetic, reading some French, and reading in Latin portions of Caesar, Virgil, and Cicero, with a full course in Latin Grammar. At various times, his teachers were Susan Sanders, Mr. Peyton, Castello, Jenkins (B. W.), Jenkins (William), F. J. Sanders, Joseph Augley, Mr. Quinn, and Arthur Buist.

In Sept. 1864, when just 17, he volunteered in the 2nd S. C. Artillery (Regt., Lamar's), served 5 months on James Island, went "on the March" from Charleston, Feb. 17, 1865, up the coast of the Carolinas, fought in the two battles of Averysboro and Bentonville, Mich. 1865, afterwards moving on as far as Greensboro, N. C., where his command surrendered, April 26, 1865, under Gen. Joseph E. Johnston.

As a boy, leisure time was given to hunting, fishing, swimming, riding horses, goats and calves, and such sports as ballgames, marbles, and the like. At the age of thirteen, was received into Mt. Olivet Church, being baptized by Rev. Jas. F. Buist, Sept., 1860. Had been a member of the Sunday school for some years, and at 18 years of age was chosen Sunday School Superintendent. In Sept., 1866, began to preach, being nearly 19 years old. Entered Furman University Feb., 1867, and graduated June, 1871. Sept., 1871, went as a student to the Southern Baptist Theological Seminary,

Greenville, S.C., graduating, "full course," May 1875. June 15, 1875, began pastorate of Chester Baptist Church, was happy and blessed there till January, 1893, when he became pastor at Florence, S. C., being prospered there in a good work of four years. While in Chester preached 5 years at Blackstock. Jan. 1897, moved to Greenville, S. C., located in the City and preached, from time to time, in Honea Path, Pendleton, at Clemson College, Limestone Church (at the College), and to various other Churches. Served Mine Church 10 years, and Steel Creek 8 years and preached to other Churches in Barnwell County.

Had one year's supply pastorate of Second Church, Columbia, and over two years of First Church of Charleston (1915-1917), being greatly blessed in this field, but forced to resign by failure of health. At Chester, Florence and Kline led the congregations in building nice houses of worship, and a parsonage at Chester. Baptized and married many people during a ministry of more than a half century.

Was ordained by Rev. J. A. Lawton and Rev. William Brooker, Aug. 1870, at the request of Mt. Olivet Church. Through 50 years, wrote articles (many) for Religious and Secular Papers, and published "History of Adelpian Society," and a pamphlet on "Ante-Nicene Fathers on Baptism." Prepared Manuscripts on "Life and Labors of Dr. Thomas Curtis," "Furman Memorial Volume," and other topics, not yet published.

June 10th, 1874, was most happily married to Miss Emmie R. Addison, Greenville, S. C., ceremony by Dr. J. C. Furnian. From this union were born two sons, James Elford and Robert Addison. "J. E." was married to Evi Jones, Florence, S.C., a graduate of "G. F. C." class 1896, to whom is given one bright child, Helen. He graduated "A. B." of Furman, 1896, taught 10 years, but is now in business. "Robert A." married Fannie Johnston, Danville, Va. He is active in business. Both sons reside in Greenville, S.C., this March, 1920. To his wife Robert Wilson Sanders owes much of his usefulness and happiness. He feels now, in his seventy third year, most grateful to God for a life so long,

...design and use patented fixtures and equipment throughout the store.

...franchise independent grocers to operate under the self-service method of food merchandising.

What happened to Saunders?

After Saunders' disassociation with Piggly Wiggly®, he opened a chain of stores which operated under the name "Clarence Saunders, Sole Owner of My Name Stores," and although it was successful, the Depression forced Saunders to close the chain. Then, in 1937, Saunders designed and constructed a prototype of an automated store, which he called the "Keedoozle" (for "Key Does All").

Saunders had once again captured the country's attention with his latest venture; however, mechanical failures eventually closed the store. Until the time of his death in October, 1953, Saunders was developing plans for another automatic store system called the "Foodelectric." But the store, which was to be located two blocks from the first Piggly Wiggly store, never opened.

Clarence Saunders never fulfilled his dream of opening a truly automated store. Sadly, his death came just as the full impact of his 'better idea' for grocery merchandising was becoming apparent. Saunders' creative genius was decades ahead of his time.

Just Who Was the Clarence Saunders Who Started Piggly Wiggly?

The following was received from Ann Boone Call, 716 Winding Way, Bartlesville, OK 74006-4434, <Marlin1869@cs.com> along with the "tip" that a Clarence Saunders founded the Piggly Wiggly Stores. (See pages one and two.)

I haven't read much about this Saunders [the founder of Piggly Wigglys] until recently a lady (Joan Dorman) in Texarkana sent me part of the following information below regarding a Saunders family somehow related to my Great Grandfather Hardy Holman Saunders, born in 1816, who married Catherine Anne Clampet in 1835 Madison County, Alabama. Their son, and my Grandfather, Andrew Masten Sanders, born 1854, who married Eliza Anne Hendren (1869-1969) in Jackson County, Alabama, homesteaded in Miller County, Arkansas nearby these same Saunders families back about 1900.

Clarence Saunders, born 1814 Guilford County, North Carolina, married Susan Josephine McRee 20 Feb 1839. She was born 10 Dec 1822 in Charlotte, North Carolina, and died 28 Dec 1901 in Hempstead Co., Ark. Clarence Saunders died in Memphis, Tenn. where he owned a grocery store.

In Texarkana, Arkansas/Texas in the 1920s there were also CLARENCE SAUNDERS GROCERY STORES. One was located on East Broad Street where my Grams Sanders would wholesale her organic grown vegetables from her garden "to a relative." This garden money enabled her to buy a new Studebaker automobile and extras for her family throughout the years. The store became PIGGLY WIGGLY in the early 1930s and moved to State Line and Magnolia Streets. Grams continued selling her produce to the store even after it became Safeway... and *Family Circle* was free at the check out stand, too.

When the new Piggly Wiggly opened in the mid-1940s across from the Texas-side high school, produce from small independent growers were no longer accepted, so Grams at age 75 years young, hit the Mom and Pop Stores in the neighborhood. I can still see her today walking behind her old horse and plow, tilling the soil preparing for her annual spring crop which never failed to be bountiful... and her rhubarb pies were really yummy!

Clarence and Susan McRee Saunders children were:

#1. Rosine Saunders, born Nov 1844 Greensboro, Guilford Co., N. C. who married N. O. Battle on 5 Dec 1866 in Lafayette Co., Arkansas.

#2. William McRee Saunders, born 15 Jan 1845, Tippan Co., Mississippi, died in 1889 leaving his widow, Elizabeth Cornelia "Eliza" Waddle Saunders with five children to raise. They were: William Forrest, born 30 Nov 1880, Mt. Moriah, Ark. ~ died 10 Apr 1955; Mary Beulah, born 10 Feb 1882, Nevada Co., Ark. ~ died 6 Oct 1961 Hempstead Co., Ark.; Phoebe Josephine, born 6 Jul 1883, Nevada County ~ died 7 Mar 1969 Midland, Sebastian Co., Ark.; Lizzie, born 19 Mar 1885, Hempstead County ~ died 20 Jul 1973 Hempstead Co.; Lacy, twin to Lizzy ~ died 24 Aug 1885 Hempstead Co.; George L., born 15 May 1887 Nevada ~ died 26 Jul 1887; Barton M., born 19 Dec 1888 ~ died 7 Mar 1966 Nevada. "Eliza" was born 5 Aug 1858 in Nevada County and was married there on 28 Jan 1880; the daughter of Archibald Waddle and Martha Kelso. Eliza died in 1944.

#3. Mary L. Saunders, born 3 Sep 1847 in Clarksville, Tennessee.

#4. L. L. Saunders, born 1848, married Margaret Lacy who was born 27 Mar 1849 in Greensboro, Guilford County, North Carolina.

#5. Sarah Josephine Saunders, born 29 Aug 1861.

What I consider to be a "clincher" as to these Saunders being family kin was in reading the following from Joan: "Granny Saunders lived in Sutton, Arkansas. We always took 'white bread' because all their bread was home baked and 'bought bread' was a treat. They had an 'outdoor privy' and that was unusual to us. Granny always killed some of the chickens that were running around her yard, and made a big platter of fried chicken with mashed potatoes and gravy with big glasses of buttermilk. It was delicious! She wouldn't let us eat any of the 'bought bread' as that was for them... for later!"

Not six months ago, before receiving these papers, I had quizzed my "older than me" first cousin, Nona Goodson, about people and things that occurred around Fouke and Texarkana before I came along, and the above story was almost verbatim about always taking a loaf of "store bought bread" to Sanders relatives in the very same area of

Arkansas each time they went to visit back in the early 1930s. I certainly would like connection proof back to Clarence Saunders, born 1814, and my Great Grandfather Hardy Holman Saunders, born 1816.

Anne Call also had this to say about the Clarence Saunders who started Piggly Wiggly: He married Carolyn Walker from Illinois in October of 1903. They built a mansion using the architect Hubert Thomas McGee to build "Cla-Le-Clare," their home, named after their three children, Clarence, Lee, and Amy Clare. ■

Bartlett Sanders Enlisted, Died Young in Civil War

The first information on Bartlett Sanders, whose parents were Bartlett Sanders (1815-1875) and Clarkey Jane Russell (1817-1901), was in the 1850 Indiana census, Montgomery County, Clark Township, page 514:

Bartlett Sanders, 38, N.C., Farmer
Clarky Sanders, 31, Ky., attd school
Barnabus Sanders, 14, Ind., school
Eliza J. Sanders, 10, Ind., school
Irvin W. Sanders, 8, Ind., school
Bartlett Sanders, 4, Ind., school
James M. Sanders, 2, Ind.

Bartlett enlisted 19 Feb 1862 at Frankfort, Ind. (at about 16 years of age) He re-enlisted 15 Feb 1864 at Chattanooga, Tenn. He was captured by Confederates 2 Jun 1864 at New Hope, Georgia; was paroled by Confederates 11 Dec 1864 at Charleston, S.C., due to illness; and reported to Annapolis, Md., U.S. Hospital 17 Dec 1864. He died there 12 Jan 1865 and is buried at Ash Grove United States Cemetery in Annapolis, now the Annapolis National Cemetery. He was in Co. E, 40th Indiana Volunteers. ■

Paul Saunders Sends Us This Horror Tale of Jolly Ole England; Read It With Caution

Elizabeth Saunders, daughter of Thomas Saunders of Sibbertoft and sister of Laurence Saunders, the martyr, was married to Thomas Catesby, esq. of Hinton, Northants. Her husband was the grandson of Sir William Catesby, High Sheriff of Northamptonshire, who was involved in a horrible example of 15th century justice, as described in an ancient printed black-letter account attached to a vellum charter of Edward IV's time, granting the Manor of Cloford to William Collingbourne, 10 Nov 5 Edw IV (1465), viz:

"1484. In these daies were chiefe rulers about the King (Richard III) the Lord Lovel, and two gentlemen, being named Sir Richard Ratcliffe and Sir William Catesby, of which persons was made a seditious rime and fast'ned upon the crosses in Cheape and other places of the Citie, whereof the sentence was as follows:

The Catte, the Ratte, and Lovel our dogge

Rulen all England under an Hogge'

"Which was to meane these three persons ruled this land under the King, which bare a white boar for his cognisance. For the devisers of this rime much search was made and sundry accused to their great charges. But finally, two gentlemen, Turburville and Collingbourne, were for that and other things laid to their charge, arrested and cast into prison, for whom shortly was holden at the Guildhall an Oyer determiner, where the two gentlemen were arraigned, and one of them called William Collingbourne Esquire convict of that crime and other, for the which he was drawne unto the Tower Hill and there full cruelly put to death [the ordinary sentence for high treason of hanging, cutting down alive and drawing out of the internal organs and usually quartering], as the which torment was so speedily done, that when the butcher pulled out his heart, he spake and said Jesus, Jesus!

"This man was greatly mourned of the people for his goodly personage and favour of visage; he had been sometime, to whit the 15 of Edward the Fourth,

Sheriff of Wiltshire, and in the 17 Sheriff of Somersetshire and Dorsetshire."

It appears that the second charge against Collingbourne was the real reason he was killed, however: "that on July 10 he had offered one Thomas Yate £8 to bear a message to Henry Tudor urging him to land in the south of England in the fall and advising him to tell the French court that the English King would only trifle with their envoys since he meant to make war on France.

"On November 29 Richard appointed to hear the case a commission of great dignity... The trial took place at Guildhall in early December. John Turburvyle was sentenced to prison. [William] Colyngbourne was convicted of treason and condemned to death. He was executed in the fashion which this age, and the next, reserved for traitors. First he was hanged, at Tower Hill, on a new pair of gallows and then, Fabyan records, 'cut down, being alive, and his bowels ripped out of his belly and cast into the fire there by him, and lived till the butcher put his hand into the bulk of his body, insomuch that he said at the same instant, 'O Lord Jesus, yet more trouble', and so died..."

Elijah Edward Sanders Traveled Tennessee to Texas; Anyone Know His Ancestry?

Thomas Sanders of Bakerstown in Allegheny County, Pa., Came From Derbyshire, England

From *The History of Allegheny County, Pennsylvania*, A. Warner & Co.; 1889.

THOMAS SANDERS, farmer, Bakerstown, was born in Derbyshire, England in 1820, son of John and Elizabeth (Kent) Sanders, former of whom was born fourteen miles north of here, at Duffield, and died September 30, 1867, aged 78 years; the latter was born in Derbyshire and died 1859, aged 66 years. They immigrated to America in 1830, remaining from July until the following fall in Baltimore, Md., and came over the mountains in wagons, settling in Butler County. They lived on different farms in Bakerstown until 1849, when they purchased the place Thomas now lives on and where his parents died. They are members of the M.P. Church, the present church at Bakerstown being organized by John Sanders in 1838; prior to that time Methodist meetings were held at his house. The paternal grandfather of our subject was William, and his great grandfather was William; the latter lived to the age of 106. Thomas says

that from 1848-1860, owing to the hard times under democratic administration he was obliged to go to New Orleans during the winter and cut cordwood, returning home in the summer.

When 28 years of age he began life for himself on present farm. In 1845 he was married to Kezia Langdon, born on the coast of Cornwall, England, a daughter of Thomas and Elizabeth Jane (Trabillcock) Langdon, who came to America about the same time as Thomas Sanders, settling in the east, where Mr. Langdon carried on a brewery; both of her parents are now deceased. Mr. and Mrs. Sanders have 8 children, six living and two deceased. Those who are living are William Crooks, Mary (Mrs. John Weber), Thomas, Maria, Charles Sumner, and Evangeline, all of whom have received a good education. Elizabeth Jane died 1863, aged 13, and Augustus Miller died 1873, aged 8. Mr. Sanders has a farm of 62 acres, after selling part of it to his son. He has been successful in business life. ■
