Robert Sanders Had Big Part In Settling Poughkeepsie, N.Y. In 17th Century

This was submitted by Robert W. Sanders of Gardnersville, Nevada. It is from a publication of the Poughkeepsie (N.Y.) Chamber of Commerce, and they credit it as excerpts from *How the City of Poughkeepsie was Founded*, by Helen Wilkinson Reynolds.

"Late in the seventeenth century, two white men were living in Albany and bought from the Indian owners a large tract of land, part of which the City of Poughkeepsie now occupies. One of the two men was Robert Sanders, an Englishman who was widely known as an interpreter between Indians and Europeans. The other was Myndert Harmense Van Den Bogaerd a Dutchman of whom it was customary to speak as Myndert Harmense. These two partners reported to the Governor of New York their purchase of land from the Indians and received from the Governor legal confirmation of their title.

"It was the purpose of Robert Sanders and Hyndert Harmense in buying this land to sell from out the tract homestead farms to settlers and the first step they took toward getting their property opened and occupied was to enter onto an agreement with two other men at Albany, by which agreement, in the form of a lease, it was arranged that the latter should move down from Albany, should each take up forty-eight acres of land as tenants for ten years and should each build a house, cultivate crops and keep livestock.

"The two men who thus agreed to settle as tenants on the lands of Sanders and Harmense were Baltus Barents VanKleeck and Hendrick Jans Ostrom and the land that they were to take up was described in the lease and called Minnisingh and Pochkeepsin.

"The lease, signed by Robert Sanders and Hyndert Harmense as owners and by Baltus Berenti VanKleeck and Hendrick Jans Ostrom as tenants, was dated at Albany, June 9, 1687. Before

1687 a transient hunter or squatter of European ancestry occasionally have explored the woods that covered the area which is now Dutchess County, but 1687 is the earliest date now known for the establishment by white men of permanent legal residence within the boundaries of the County.

"Soon after Baltus VanKleeck and Hendrich Ostrom established themselves on the site of the City of Poughkeepsie, Myndert Harmense also arrived from Albany as a permanent resident. Among the children were two boys, Johannes VanKleeck (born, 1680) and Myndert Harmense (born 1682). Like all boys, they enjoyed wandering in the woods and they early explored the forest that surrounded their home. Soon they were familiar with the Indian trail.

"Following that trail as it ran along the course of the present Market Street, South Avenue and the State Road, they finally reached a spot about a mile and three quarters south of where the Court House now stands and there the spirit of boyish adventure had its reward. On high sloping ground they found a spring, surround by cat-tail reeds. Out of the spring issued a small stream—a stream that is still running and which, rising on the east side of the present State road, flows across the Poughkeepsie Rural Cemetery and enters the Hudson River at Mine Point. Around that spring the two little Dutch boys found Indians camping.

"The Indians had cut the cat-tail reeds, plaited the reeds into mats, hung the mats over branches and thus made 'lodges' or shelters for themselves.

"The boys called this spot 'Rust Plaetz,' a Dutch word (pronounced Roost Plawts) meaning Resting Place, because the natives rested or camped there. But the Indians themselves spoke of it in three words of their own, words well known to modern students of

Don't Shortcut Your Family Research; Utilize All Tools

Robert Tilman, CEO of RootsWeb, has said, "Only a small fraction of genealogy-related information is on the Web."

Computers have done a fantastic job of making more genealogy material available to researchers and connecting even more people than we would have ever thought possible. RootsWeb is probably the best place on the Web to get help, or receive help. Just this past year I heard from individuals who were related to me on two different lines for which I had nearly given up hope. They saw my posting on the RootsWeb Surname list that has been there for more than five years.

However, you can't just sit at that computer and expect to do all your genealogy work. I am afraid that we are getting away from some of the traditional tasks related to sound family research. Subscribers to surname newsletters are also declining. Newsletters are still a very good place to find other researchers and information not available elsewhere. You need to get out to those libraries, court houses, cemeteries, and Family History Centers. You still need to write letters to many relatives and friends who may have information you need.

Use all the tools you can. The computer is a great one! And it is one of the best tools that you can have to help write those letters.

In our busy, busy world we all want shortcuts and time savers. Don't shortcut your family research by looking for the easy way out. Keep up the traditional research. ■

Indian language: 'Uppuqui' pronounces OO-poo-kee, and meaning "Lodge covering" the name of the cat-tail reed; 'IPIS,' little water; 'ING' meaning place; a free translation of which is 'the reed-covered lodge by the little water place.'

"That spring was about half way between New York and Albany on the Indian trail and it served as a camping place for Indian runners and for local hunters. It was so well known locally that its name was applied to the general vicinity surrounding it. But when Dutchmen and Englishmen, who arrived as settlers, wrote the name they spelled it phonetically and each man heard it differently so it appears in the early documents in a great many combinations of letters." ■

Robert Roten Continues Search For Sanders Kin

Robert R. Roten, 2850 Oak Creek Drive, Paris, TX 75462, <rrr@cox-internet.com>. I continue to search for an unknown Sanders, believed to be living in South Carolina in the mid 1800s. His family which I am sure of is as follows.

MARY FRANCIS SANDERS, b. July 28, 1850 (believed to be in Darlington, S.C.) d. 20 Jun 1903 in Itasca, Texas. Married Charles Allen Rotton, believe to have been in Alabama.

DRUMMOND PUTNAM SANDERS, b. 15 Jun 1848 in Darlington, S.C. Drummond became a Baptist preacher, and was in the Texas/Okla. area. Died in Corpus Christi, Texas, 31 Oct 1917.

SALLY SANDERS, no known information whatsoever.

RICHARD B. SANDERS, b. 30 Nov 1845, d. 15 Apr 1886, Itasca, Hill Co., Texas.

Family Tree maker gives information suggesting that the unknown Sanders came from England and actually had two families. The one given above being the second family. It also suggests that the unknown Sanders served in the Civil war and was killed. I have not been able to confirm any of that information. Mary Francis Sanders was my g-g-grandmother so I am certain about the information with regards to her and also to Drummond Putnam Sanders, from family bibles and etc. It seems that I am just not able to connect the family to any known Sanders line. ■

Was Robert Sanders English or Dutch?

The following was received from Robert W. Sanders, P. O. Box 1397, Garnerville, NV 89410, <kernel@worldshare.net>. Comments and notes are his. [I don't rememebr where I got this, but I copied it from a book back in the 1970s. The original photo-copy is now fading, so I retyped it here.]

SANDERS, THOMAS, smith of Amsterdam, m. Sarah Cornelise Van Gorcum in New Amsterdam, Sept 16, 1640. She died in Albany in Dec 1669. He received a patent from Gov. Kieft for a house and 25 morgens of land on Manhattan Island. In 1654 he owned a house and lot in Beverwyck, which he sold to Jan Van Accker. He probably returned to New Amsterdam. Ch: bp. in New Amsterdam; Robert, Nov 17, 1641; Cornelis, Nov. 25, 1643; Cornelis, Nov. 17, 1644; Thomas, July 14, 1647.

SANDERS, THOMAS, bolter, of New York, son of the last had the following ch. bp. in New York: Robert, Oct 4, 1696; Styntje, Dec 24 1697; Robert, Jan 4, 1700; Jacob, Oct 19, 1701; Elsie, Oct 27, 1703; Anneke, Jan 30, 1706; Marjtje, May 13, 1708; Jacob, June 9, 1712; Beatrix, Sept. 25, 1715.

SANDERS, ROBERT, son of Thomas and Sarah Van Gorcum, smith, 1667, merchant 1692, settled in Albany as early as 1665. In 1691, he and Harmanus Myndertse Van Den Bogart received a patent for a mile square of land in Dutchess County, including the site of the city of Poughkeepsie. His first w. was Elsie Barentse; the second was Alida _____. Ch. Helena, w. of Johannes Lansing; Barent; Maria, w. of Gerrit Roseboom; Sara (?), w. of Hendrik Greefraadt; Elsie bp. July 13, 1683, buried Dec 31, 1732.

SANDERS, BARENT, mayor, 1750-4, m. Maria, dau. of Evert Wendel, Sept 19, 1704. He was buried in the church, June 22, 1738. She was buried in the church Nov 21, 1757. Ch. bp.; Robert, July 15, 1705; Maria, Dec 3, 1707; Johannes, July 12, 1814.

[NOTE: This preceding paragraph does not make sense. It is not clear who is buried in the church if Barent Sanders was still mayor after 1738. However, the paragraph is copied exactly as it appeared in the book.]

SANDERS, ROBERT, merchant, m. first Maria Lansing, Dec 6, 1740; secondly, Elizabeth Schuyler, Jan 11, 1747. His

first w. was buried in the church, Feb 15, 1743, and the second d. about 1763. He made a will May 7, 1765, proved June 6, 1765 and spoke of "my only son Pieter"; and "my late wife" Ch. bp.; Barent, Feb 6, 1743; Maria, Aug 23, 1747; Maria, Oct 22, 1749; Catharina, Feb 23, 1753; Barent, Dec. 16, 1753 buried Oct 6 1756; Pieter, Dec. 7 1755; Debora, Feb 9, 1758; Elizabeth, b. July 9, 1760; Elizabeth, bp. Dec. 20, 1761.

SANDERS, JOHANNES, m. Debora Glen, of Schenectady, Dec 6, 1739. She was the only child and heir of Col Jacob Glen of Scotia. In 1765, by the purchase of the interest of John Glen, of Albany, and John Glen Jr., of Schenectady, for £4,000, Johannes Sandes and w. became sole owners of the Glen estate in the present town of Glenville. He made a will Jan 27, 1779, proved Feb 11, 1783; in it he mentions his only son, Johannes; w. Debora, living; and daughters Maria; Sarah; Elsjje; and Margaret. He d. Sept. 13, 1782: she d. March 8, 1786. Ch. all b. in Schenectady; Maria, bp. June 14, 1740, w. of Johannes Beekman of Albany; Sarah, bp. Feb 20, 1743, m. her cousin Jno. Sanderse Glen, of Scotia; Barent, b. Aug. 6 1744, d. Nov. 21, 1746; Elizabeth, b. Dec. 5, 1758; Elsjje, bp. April 5, 1752, m. Schuyler Ten Eyck, of Schenectady; Jacob Glen, b. April 5, 1755, d. Sept. 18, 1765; Johannes, bp. Oct 23, 1757, m. his cousin Debora, dau. of Robert Sanders of Albany; Barent, b. Dec. 26, 1759, d. Dec 31, 1759; Margaret, bp. June 24, 1764, m. Kiliaan Van Rensselaer, of Claverack.

SANDERS, JOHANNES, JR. (son of the last), m. first, Debora Sanders, of Albany, Feb. 24, 1777, and secondly, Albertina Ten Broeck, of Claremont, Columbia County in 1799. His first w. d. Nov. 28, 1793, the second d. July 30, 1834. Johannes Sanders Jr., inherited his father's estate, and resided in the ancient Glen house at Scotia. Ch. b. at S.; Elizabeth, Dec. 20, 1777, m. Doct. William Anderson, d. June 21, 1850; Barent, Jan 12, 1779, d. June 5, 1854, a. 75 y.; Robert, Sept. 8, 1781, d. Oct. 25, 1783; Sarah, Aug 28, 1783, m. Peter S. Van Rensselear, d. Aug. 13, 1869, a 86 y.; Catharina, Oct 10(11), 1785, m. Gerard Beekman, of New York; Robert, July 18, 1787, d. Nov. 5, 1840; Jacob Glen, April 20(22), 1789, d. March, 1867; Peter, Feb. 17, 1792, d. May 12, 1850; John, Dec, 27, 1802; Theodore (or Derrick Wessels), Oct. 20, 1804. ■

Edgecomb and Chowan County Wills Related?

This is the will of Thomas Sanders who m. Sarah Jordan, dau of Cornelius Jordan Sr. Submitted by Gary Sanders, P. O. Box 309236, UNT Station, Denton, TX 76203-9236, <gsanders@library.unt.edu>.

Thomas Sanders (Edgecombe Co., N.C.)

"May 22, 1801. May Ct 1802. Land in Johnston Co where Jesse Sanders lives, also tract on Mash (Marsh?) Swamp, Nash Co., to be sold in order to settled just debts. Wife Sarah, lend plantation and remaining land, furniture, stock, etc. during her life. Reversion to sons Cornelius, Isaac and Luke Sanders and grsons Thomas Sanders, son of Thomas Sanders, and William Sanders son of Elisha. Daus Elender and Mary, bed and furniture each. Residue divided between my chil. and heirs of Thomas Sanders, Elisha Sanders and Sarah Barfoot, each family to have 1/8.

"Extr Charles Coleman, Isaac Sanders. Wit Bas Simms, Jethro Harrison, William White, Thomas Horn."

[Jesse Sanders who owned the land in Johnston County was not referred to as a son. Could he have been a nephew? Same as Jesse Sanders named as son in the John Sanders will of Onslow? Were John Sanders d. 1796 Onslow and Thomas Sanders d. 1802 Edgecombe brothers? If so, perhaps this is the will of their father:]

John Sanders, (Chowan County, N.C. 18 Aug 1751- Oct 1751 Will)

"John (plantation on Cypress Swamp where Thomas Rutter lives), Robert, Jesse, Thomas. To each of above-named sons is bequeathed negroes. Daughters: Mille, Feribe and Elizabeth Sanders. Wife and Executrix: Mary.

"Witnesses: John Loe (or Loce), Jr., John Loe (or Loce), Sr., Jacob Ruth.

"Clerk of the Court: James Craven." ■

East Tennessee Sanders Family In Sullivan, Washington Counties

The book, *Genealogy of the Sanders, Alison and Collateral Families of Sullivan & Washington Counties Tennessee* by W. R. Sanders was found in the Johnson City, Tenn., Public Library. It is also in many other libraries. W. R. (William Robert) was born 25 Nov 1888 and held a 1912 engineering degree from the University of Tennessee. The following is from pages 1-4:

The gathering of the records of the East Tennessee Branch of the Sanders Family has been obtained with much effort and delay. It had been hoped to have this record traced to the emigrant. However, the task of unraveling the progenitor of John Sanders 1st., from whom the East Tennessee branch of the family derive, proved too herculean for the compiler to carry through to completion.

John Sanders 1st., was born October 24, 1754. This authentic information was taken from an old family record in the possession of Michael Judson Sanders, a great grandson of John Sanders 1st. His consort, the date of his death, or the date he settled in Sullivan County are all unknown. No record can be found in the Registrar of Deeds Office in Blountville or Jonesboro, to show the date or from whom he purchased his approximately 200 acre tract of land located on the south side of the Holston river two miles upstream from the fork of the two rivers. Presumably this record, with others equally as valuable, was destroyed when the old court house, at the time of the battle of Blountville, September 22, 1863, was hit by a shell from the Federal guns, setting it on fire. However, the exact location of the old John Sanders 1st. homestead is known, and the boundary lines of the original 200 acre tract can be closely approximated from the tracts held by the John Sanders 1st. heirs.

The earliest date of record which links John Sanders with Sullivan County, is August 14, 1812, this being the date his son, John Sanders 2nd., then 27 years of age, purchased from John Sitzler, or Sitsler, a "certain tract or parcel of land situated and lying in Sullivan County on the south side of the Holston river and joining a former survey of John Sanders 1st."

JOHN SANDERS 1st (children):

The aforementioned family records in possession of Michael Judson Sanders also included a copy of the will of John Sanders 1st.:

John Sanders 1st Will

In the name of God Amen, I, John Sanders of the County of Sullivan in the state of Tennessee, being of sound mind and disposing memory, knowing that it is appointed of me to die after commending my soul to God who gave it, and my body to be buried in a Christian like manner,—To Witt—After paying just debts and funeral expenses, I bequeath to my daughter Elizabeth and my grand daughter Elizabeth Catherine, infant child of my daughter Sarah deceased, one hundred dollars each and all the household belonging to my decease, also the loom and anything appertaining to it and the bed clothing and bedsteads, likewise two cows of the first choice of my stock, all of said property to be kept by my daughter Elizabeth until my grand child above mentioned shall arrive at age, then I further bequeath to my son John all my farming utensils that may be on my plantation at my decease and further my land and all movable property not named here to fore shall be equally divided between my children and my grand child share alike Catherine, Elizabeth, John, Barbra and Elizabeth Catherine. I further request that my grand child be sent to school at the proper age and provided it should die before it arrives at age the part bequeathed to it shall descend equally to my four children above mentioned.

This copy of the will was not dated. However, mention of his deceased daughter, Sarah, would be proof that the will was drawn some time after 1832, this being the known date of Sarah's death. No mention of his consort is made so we must assume that she was deceased.

The burial place of John Sanders 1st., his wife, daughters Elizabeth, Barbra, Sarah, sons Henry and Abraham are unknown. In view of the fact the old Goodman family cemetery was located

on the John Sanders 1st. tract, and in close proximity of the old home, it would only be logical to assume this was their final resting place. The Goodman Cemetery was one of many which fell within the reservoir of the TVA lake. In the year 1952, many of the remains were removed from this old cemetery to the present location of the new Goodman Cemetery. However, a good number of the unmarked graves were not disturbed and we have every reason to believe the members of the Sanders family mentioned here are included in these unmarked graves. ■

Moves of William Jasper Sanders and Family Found Recorded In Library

The following was found in the verticle files of the genealogy section of the Fayetteville (Ark.) Public Library. It is a partial family record and was evidently compiled several years ago, likely not long after 1965. It may be partially copied from a Family Bible.

WILLIAM JASPER SANDERS and LOUISE PHEMISTER were married February 5, 1882 in Marion, Illinois. [Another page seems to indicate that his parents were Dempsey Steveson Sanders (1 Sep 1824 - 22 Mar 1894) and Ellender Mercy Wood (28 Sep 1830 - 6 Dec 1866.)

They moved to Wright County, Missouri and lived there about seven months. Leaving Missouri, they went to Cartersville, Illinois and stayed there for about two years when they moved to Bonham, Texas and lived there for six years after which they moved to Fayetteville, Arkansas. They lived in Fayetteville for about forty-five years, then they moved to Farmington, Arkansas and lived there until the death of Mrs. Sanders on April 22, 1936. Mr. Sanders then moved to Van Nuys, California on August of 1936—where he is now living.

Records Indicate That Some Sanders in Virginia Came From Norway By Way of England

This is from "Beryl's Family File" at <<http://homepages.rootsweb.com>>.

Sanders Ancestry Leading to John Sanders (b. 1740) of Goochland, Virginia. These Sanders were from Norway, where they used the name Sønders (spelled with a slash through the "o") They migrated to Wales and then to Wiltshire, England, and from there to America. They settled in Salem, Mass. in 1630. The name was spelled Sanders, but pronounced Saunders because they had no knowledge of how to write the "ah" sound in English. The arms were a chevron between three elephant heads. The family motto was "To be conscious of no guilt, and to turn pale at no charge" (original in Latin).

Henry Sanders, b. abt. 1552 in Downton, Wiltshire, England; m. 1572 at Downton, Wiltshire, England; Wife: Sibyl, b. abt. 1552.

John Sanders, b. abt. 1578 in Weeks, Downton Parish, Wiltshire, England; m. 4 Feb 1610 at Downton, Wiltshire, England; d. 10 Jul 1670 in Salem, Mass.; Wife: Alys Cole, b. 1591 at Downton Parish, d. Salem, Plymouth, Mass.; Other wives: Hester Rolfe and Sara. John had 2 children with Alys, including John, b. 26 May 1613. John also had 5 children with Sara and 9 with Hester. He was allowed to begin a plantation called Merrimack at Salisbury, Mass. on 7 Jun 1638.

John Sanders, b. 26 May 1613 in Weeks, Dainton Parish, Wiltshire, England; m. 1639 at Whiteparish, Wilts,

England; d. 28 Sep 1643 in Newbury, Essex, Mass.; Wife: Pricilla Elizabeth Grafton, b. abt. 1613. This John came to America with his father in 1630. He was a Salem proprietor farmer on 25 May 1636, a Marblehead proprietor farmer in 1639, and a deputy in 1642. He had 2 sons, the first being Capt. John, b. Dec 1640.

Capt. John Sanders, b. Dec 1640 in Salem, Mass.; d. 26 Nov 1694 in Salem, Mass.; Wife: Hannah Pickman, b. abt. 1643.

Capt. John's will was probated on 26 Nov 1694. His third son was Nathaniel, b. abt. 1668.

Nathaniel Sanders, b. abt. 1668; d. 1731 in King & Queen Co., Va.; Wife: Unknown. Nathaniel was a farmer and had 5 sons and several daughters. His first son was Philip, b. 1694. His will is on pages 121-122 in the Saunders book.

Philip Sanders, b. 1694 in Carolina Co., Va.; d. 9 Dec 1722 in Westmorland Co., Va.; Wife: Elizabeth Graves, b. abt. 1691. Philip's will was dated 6 Apr 1723. He had at least one child, William, b. 1717.
