## Frank Sanders' Murder Described In Newspaper Account— "Killing At Big Pine"

The following are newspaper accounts of the murder of Frank Sanders on Christmas day, 1908: *Inyo Independent*, Inyo County, California, December 25, 1908. This was submitted by Bettie Killgore, 208 Esmeralda Drive, Santa Cruz, CA 95060-1918, <bettieellen@aol.com>.

### "Killing at Big Pine"

Just as we go to press it is learned that Frank Sanders was shot and killed by a man named Lovett. The killing was done with a rifle, three shots having been fired and all taking effect. It is reported that Lovett is now barricaded at his home and defies the officers. Sheriff Naylor and Deputy Sheriff McDonald left immediately for the scene of the killing as soon as word was received. Both deceased and Lovett are well known in the county, having lived here for a number of years.

### "Killing of Frank Sanders"

The following is the testimony of Elias W. Sanders, brother of the deceased, and an eye witness to this tragedy, and Dr. C. E. Turner who made an autopsy of the remains. Several other witnesses testified at the inquest but no material facts other than these elicited were brought out.

### DEPOSITION OF ELIAS W SANDERS

Q. Where were you on December 25, 1908?

A. I was in Big Pine at my residence.

Q. Did you know Frank Sanders?

A. I did.

Q. Is he alive or dead at this time?

A. He is dead.

Q. When did he die?

A. He died on December 25, 1908 at Big Pine.

Q. What was his name in full?

A. James Franklin Sanders.

Q. What was his age?

A. Forty three.

Q. What was his nativity?

A. He was born in Arkansas

Q. Was he married or single?

A. Single.

Q. What was the cause of his death, do you know?

A. He was shot.

Q. By whom, do you know?

A. Supposed to be Morris J. Lovett.

Q. State what occurred in so far as you know in connection with the death of the deceased?

A. I went down to my mother's after being there a few minutes my wife came down and said, "Lovett shot one of my chickens." My brother, B. H. Sanders, and I together with my wife went back up to my house and I proposed to go and get the chicken. My brother told me he'd go and get the chicken, for me not to go. I said, "You go get the chicken and I'll go to town and see if I can have him arrested." And my brother, B. H., went up and got the chicken, where it was lying near the corner of Mr. Lovett's house, carried the chicken at distance towards my house. When I stopped him and told him to leave the chicken as evidence. He left it. I went on down to town and went before Judge Uhlmeier and applied for a warrant. Judge Uhlmeier informed me that there was no law against shooting chickens if they were on anyone else's premises. My brothers Frank and B. H. and myself walked down the street by Mr. Lovett's house to where the chicken was lying. I suggested that we pick the chicken up and take it to the home. Either my brother Frank or I (don't remember just which) picked the chicken up and Frank said, "I'll throw it over in the yard and give it to him since he's killed it." Walked back with the chicken, turned fronting the door and started as if to throw the chicken in the yard. A shot was fired. Frank staggered back. I said,

## Robert Sanders Seems to be the Brick Wall Facing Jerry Sanders; DNA Testing is Helping

I want to say first that my cousin Janet Tranum has done the lion's share of the Sanders' research and is much better versed in our history. While it was my idea to write it, this article is actually a collaboration between the two of us. Our ggg grandfather Robert Sanders was born about 1800, we think in North Carolina, possibly Chatham Co. After years of research we have been unable to determine who his father was. This article is an attempt to find other folks that may be researching this, or branches of, this family that can help us prove, or disprove, the theories set forth here.

What we do know for sure is that Robert was in Morgan Co., Georgia in 1826. He married Sarah Phillips there on 12 Dec 1826. Their first three children, James A. Sanders, b. 1828, Joseph B. Sanders, b. 1830, and John Thomas Sanders, b. 1834, were born in Morgan Co., Ga. In addition to Robert, we know that George Sanders/Saunders, b. 15 Feb 1769 in Chatham Co., N.C. lived in Morgan Co. and died there in 1826. Further, DNA testing shows that in 25 markers, George and I were one away, in one category, from being an exact match. Now, according to Justin Sanders, that means that George is my ancestor and we are related about 150-200 years ago. Janet and I speculate that Robert's father may have been a brother to George.

From what we can find, George had a brother named James. James was born in Chatham Co., N.C. He moved to Oglethorpe Co., Ga. and lived there for a while, but moved back to Chatham Co. where he lived until moving to Tallapoosa Co., Alabama. Here is where the story gets interesting.

Some time between 1834 and 1836, Robert moved to Tallapoosa Co., Ala. Robert's next child, Jane K. Sanders, was born in Tallapoosa Co. in 1836. In May 1839, four Sanders men bought land in Tallapoosa Co. on the same day. They were Robert, James, William, and Zach

Sanders. The James Sanders was a brother to George Sanders mentioned before. Based only on age, it is possible James could have been Robert's father. James Sanders died in Tallapoosa Co. and we are almost sure Robert did as well. Robert's last child, Jefferson Harris Sanders, was born in Tallapoosa Co. in June 1846. Sarah and the children turned up in Newton Co., Miss. in 1850 without Robert. Based on that, we think Robert died in Ala. We can find no evidence of Robert between 1846 and 1850 in Ala. or Miss.

We have researched the probate records and wills of Tallapoosa Co. and came up with nothing. If the records are complete it appears that neither James, nor Robert, had a will and we can find nothing in land records where their land was sold. We really thought those records would contain information that would link James and Robert together. We were disappointed again.

We believe that there is every possibility that James Sanders is Robert's father. All we have at this point is circumstantial evidence, so we really need to find a descendent of James' to take a DNA test; hence the reason for this article. If you are a descendent of James Sanders/Saunders, or George Sanders/ Saunders, we sure would appreciate it if you would contact us. I will personally pay for the DNA test if that is what it takes to get someone to participate. The fact that George, Robert, and James Sanders lived so close to each other for so long gives us reason to believe they are related; just how, we don't know at this point. If you can shed any light on this we would like to hear from you. ■

### Wants to Go Further Back

"Are you hit?" He said, "Yes I am," and I started to go to him, and he retreated backwards some few feet. When the second shot fired he turned then almost facing the West and staggered some few feet and fell. I went to him, knelt over him and got his head in my hands, when a third shot fired. I raised up from where he lay, and went down in front of Lovett's gate- - then turned and went for the officer.

Q. You referred to James Franklin Sanders as Frank?

A. Yes sir.

Q. One and the same person?

A. Yes sir.

Q. Where was he standing, the deceased in reference to Lovett's house.

A. I would judge ten or fifteen feet from Lovett's gate.

Q. And how far from the house?

A. It must be some twenty feet from the house.

Q. Where was he at the time in the yard or in the street?

A. He was on the street.

Q. And he was in the act of throwing the chicken into the yard?

A. Yes, sir.

Q. Where was the first shot fired from if you know?

A. From in the house.

Q. Through what part?

A. Through a screen door.

Q. Where was the second shot fired from?

A. From the house also, through the screen door.

Q. About how much time lapsed between first and second shot?

A. I would say almost in succession like a man shooting quail.

Q. Was it before or after second shot that deceased stated that he was shot?

A. Between the two shots.

Q. Prior to the shooting or during time of shooting were words exchanged between deceased and anyone in the house?

A. No.

Q. Did you see a weapon in the hand of the deceased at any time during the occurrence?

A. I did not.

Q. Did you find a weapon of any kind on or near the premises where he fell?

- A. I did not.  
 Q. Did you have a weapon with you?  
 A. I did.  
 Q. How did you carry it?  
 A. Just under my pants.  
 Q. Did you take it from where you carried it at any time?  
 A. I did.  
 Q. What particular time?  
 A. When the third shot was fired.  
 Q. Where and in what position were you at that time.  
 A. I was over--crouched, like this.  
 Q. That is, over the deceased?  
 A. Yes.  
 Q. How long after the second was the first shot fired?  
 A. A space of time--I could not state--quite a little space.  
 Q. Did you pay any attention to the first two shots?  
 A. No. Only it seems as if they were muffled. The first two shots sounded the same.  
 Q. Did the third shot strike any person.  
 A. I don't think it did.  
 Q. Do you know how long the deceased and M. J. Lovett were acquainted?  
 A. Very short acquaintance.  
 Q. How long?  
 A. I don't think they were ever acquainted.  
 Q. Do you know where there had been any trouble between them?  
 A. If there has, I don't know it. I don't think there has.  
 Q. Who besides yourself and the deceased was near there.  
 A. My brother, B. H. Sanders.  
 Q. This to which you testified occurred in Inyo County, California?  
 A. Yes sir.  
 Q. Were you present where deceased was searched?  
 A. No sir.

- Q. State whether or not you were called upon on Dec. 25, 1908, to examine the remains of a deceased person?  
 A. About what time of day?  
 Q. Coroner Robinson spoke to me about 11 a.m. requesting me to perform an autopsy on the remains of J. F. Sanders.

- A. Did you see J. F. Sanders or his remains about that time.  
 A. I saw his remains previous to that but I had not been called to see them.  
 Q. Was he alive or dead when you first saw him on December 25, 1908  
 A. Dead  
 Q. Did you make an examination of his remains on December 25?  
 A. I simply felt his pulse, which I found absent.  
 Q. That was on your first visit?  
 A. First visit.  
 Q. Did you or not later on the same day hold an autopsy of J. F. Sanders?  
 A. I did--about 3 p.m.  
 Q. From your examination of the body what in your opinion was the immediate cause of his death?  
 A. Shock and hemorrhage due to numerous gun-shot wounds.  
 Q. What wounds did you find on his person? Describe what you found in connection?

A. I found 109 gun-shot wounds, involving the right and left lungs, heart, arch of aorta, liver and large intestines. I state only fatal wounds--there are also wounds on right arm and neck.

Q. There were four wounds at the base of the heart. Any one of which would prove fatal. Four perforations on the arch of the aorta, any one of which would prove fatal. Six or seven perforations of the liver. Entire right lung destroyed. left lung punctured with 5 shots. Three perforations in the transverse colon. These Mr. Dehy I consider the fatal wounds, any one of which would prove fatal.

Q. What foreign substance if any did you find in connection with these wounds?

- A. Leaden pellets.  
 Q. Did you preserve any?  
 A. I preserved some, four of which I produce.

The following is the verdict of the Coroner's Jury.

In the matter of the Inquisition upon the Body of James Franklin Sanders, Deceased.

We the undersigned, Jurors summoned to appear before H. H. Robinson, Coroner of the County of Inyo, at Big Pine, on the 26th day of December, A.D. 1908, to inquire into the cause of the death of James Franklin Sanders, having been sworn according to law, and having made such inquisition after inspecting the body, and hearing the testimony adduced, upon our oaths, each and all do say, that the deceased was named James Franklin Sanders, was a native of Arkansas, aged 43 years, that he came to his death on the 25th day of December, A.D. 1908, in this county, by gunshot wounds inflicted by one M. J. Lovett in the borough of Big Pine, Inyo County, California.

All of which we certify by this inquisition, in writing, by us signed, this 26th day of December, A.D. 1908.

## Debunking Certain Myths About Laurence Saunders, the Martyr

MANY MEMBERS OF THE SANDERS/ SAUNDERS FAMILY around the world have been led to believe that they are descendants of Laurence Saunders, a theologian who was burned at the stake at Coventry on 8 Feb 1555. Laurence was a Christian Martyr who had rejected the theology of Roman Catholicism and would not renounce his views nor give up his clerical office as required by Mary Tudor when she became Queen in 1553. It was primarily this which caused Laurence to be executed in the first place. We know that Laurence had married "in late summer 1548, ignoring the convention of clerical celibacy"<sup>1</sup>, but did he leave any descendants? So far as is known, Laurence had but one son, Samuel, who was still a babe in arms while Laurence was in prison between Oct 1553 and Feb 1555.<sup>2</sup> Samuel and his mother were entrusted by Laurence to the care of a "Mistress Lucy Harrington" if he should be executed, as expected. She had been his close friend and patroness and in several extant letters he asked her to take his wife and child under her wing after he died.<sup>3</sup> It now appears that she did just that.

There are three myths about this man which I would like to address, namely:

1) A Lawrence Sanders was born in Cambridge, England, 9 July 1510 according to several sources based upon records contained in a 16th Century Bible, now lost.<sup>a,b,c</sup> The claim is made that he was the same man who was burned at the stake in 1555. His parents are given as John Sanders and Jane Lawrence.<sup>a,b</sup> In a 1996 book, based on the work of Edith Whitley located in the city library of Franklin, Tenn., the claim is made that Lawrence was born on the same date, but at Harrington, Northants, and that his parents were instead Thomas Saunders and wife Margaret Cave.<sup>c</sup> Birthplace and parents were apparently changed from the earlier works to agree with the known facts about Laurence Saunders, the Martyr.

The Martyr is known to have been the son of Thomas Saunders of Sibbertoft, Northamptonshire, by his wife Margaret Cave.<sup>4</sup> He was born at Welford, Northants, in 1519 and the family moved to Sibbertoft by the mid-1520s.<sup>1</sup>

As a boy, Laurence was sent to study at Eton and was graduated by 1538 when he was selected for King's College, Cambridge.<sup>5</sup> By this time he must have been about nineteen years old as one of the rules of Eton required that "every scholar shall be dismissed the college on the completion of his eighteenth year, unless his name be on the indenture for King's, in which case he may stay until the age of nineteen."<sup>6</sup> Thus, Lawrence Sanders (b.1510) cannot have been the Martyr.

2) A claim is made on the internet that the wife and son of the Martyr "fled to Holland where they were allowed to worship as they pleased." Two generations passed with no record kept until the recorded marriage of his great-grandson, Thomas (a silversmith of Amsterdam) to Cornelise Von Gorcum in 1640.<sup>d</sup> This appears to be based upon a 1911 book edited by Cuyler Reynolds which claims much the same thing and adds that the family arms included three bulls' heads.<sup>e</sup> Those were not the arms of the Martyr's family, however, which instead incorporated three elephants' heads.<sup>13</sup>

As recently as 1903 the author of a biography of Laurence does not seem to have known what became of Mrs. Saunders and Samuel after the execution, nor even his wife's name.<sup>7</sup> However, in a 1943 history of Eton College it was revealed that her first name was Joanna.<sup>8</sup> By 1938 another researcher had found that Joanna went to Frankfurt am Main (Germany) with Lucy Harrington and her husband Robert after Laurence's execution.<sup>9</sup> The author surmises that Joanna acted as their maid in Germany, but this is unproven. However, Lucy died before 18 June 1556, as Robert Harrington was then married to "Joanna, 'honesta Joanna Harritoni', once wife to Laurence Saunders, but now true wife to Robert Harrington, citizen (Jung, p.51)."<sup>10</sup> On the Frankfurt dwelling-list of 10 June 1557, Robert Harrington is shown with "wife, one child and a maid" in his household, but new research by Doreen Agutter of Coventry, England, has revealed that this child was an infant daughter.<sup>11</sup> Mrs. Agutter said, "The Frankfurt exiles all returned speedily home on the accession of Elizabeth [1558]. Robert, who had trained for the Ministry received a living at Hornsey in

Middlesex in 1560, which he retained until his death 50 years later." By 1599 Joanna must have died because Robert Harrington was married to Julianna Mellowe (as his 3rd wife) that year at Islington.<sup>12</sup> No further information on his stepson Samuel has been found. He might have died before Joanna went into exile, as infant death was very common then, or he might have been left with relatives in England. He does not appear again in English or German records, at any rate. He and Joanna never went to Holland, so far as is known. So, the descent of Thomas Sanders, silversmith of Amsterdam, from the Martyr, is very doubtful.

3) He was said to be an "ancestor" of Tobias Saunders (ca.1625-1695) of Westerly, Rhode Island, and Tobias was said to have been a member of the King's Life Guard in old England before he emigrated.<sup>14</sup> The King's Life Guard was established in 1639 by members of the Royalist gentry who were faithful to the monarchy, to protect the life of King Charles 1st who was then being threatened by an increasingly recalcitrant Parliament. This culminated in his defeat by the Parliamentary army led by Oliver Cromwell at Naseby, Northamptonshire, in 1645. Tobias had emigrated to America before August 1643, at which time he is found on a militia list of men between 16 and 60 years of age at Taunton, Mass.<sup>15</sup> If he had been a member of the gentry and loyal to the King, why would he emigrate to a new land and begin life again as a laborer at the Iron Works in Saugus, Massachusetts, where he was a witness in court cases in 1649 and 1650?<sup>16</sup> It just didn't make sense, so I began to look into the life of the Martyr to see if Tobias could have been his descendant who had left England for religious reasons.

Tobias became a member of the Seventh Day Baptist Church in Newport, R.I., sometime after moving there about 1654,<sup>17</sup> as he is on the membership roll of 1692.<sup>18</sup> This shows that he was probably not a member of the established church of England, at least not after he emigrated. I have found no proof that he suffered persecution in England before he emigrated, however. Tobias was my immigrant ancestor and I have searched for a connection between him and the

Saunders family of Northants, or Laurence Saunders, for thirty years without success. There does not seem to have ever been a Tobias in the Northants family, so I think this family legend is also false.

**Conclusion:**

These three family stories have all been stated forcefully and without any qualifiers in several printed sources, but no proof can be found to verify any of them. I therefore conclude that it is unlikely that any of us can truthfully claim descent from Laurence Saunders, the Martyr. I invite anyone to produce proof to the contrary.

Their children are 1) William Harrison, b. 31 May 1831 in Virginia; 2) Jesse James, b. abt 1833 Virginia; 3) Abner John "AI" Saunders born abt 1838 probably in Missouri (Osage County); and 4) Mary A. Saunders born abt 1839 probably Missouri (Osage Co.).

William, Jesse and AI all married the Quick sisters; William married Elizabeth Ann Quick; Jesse married Sarah Ann and AI married Mary Jane Quick. Thanks to answers to my query and some further searching on my part, I found that the listing is sometimes Obededom and sometimes Obededone. In all places he was married to Maribah/Marribah Stone. I think confusion was caused because he was called Obed.

Although my Sanders/Saunders were born in the east, they migrated to the Indiana/Illinois area in the early 1800s. My gggrandfather, Belamine Lemine Sanders, was born in 1803 in New York; my ggrandfather, Ezra/Ezria Sanders was born in 1834 in Rising Sun, Indiana and died in 1916 in Illinois. I have found a lot of Sanders 'cousins' who claim Belamine but I have yet to find any who have Ezra/Ezria and either Nancy Emeline Perry or Caroline Shaw on their tree. Ezra and Nancy's daughter, Mary Jane, is my grandmother. The story goes that when Nancy died (about 1890), Ezra remarried to Caroline in 1893. My mom said that Caroline was 'mean' to grandma and her siblings and was always berating them. I know Mom was born in 1906 and she didn't like Caroline at all. As far as I know my Sanders side didn't do anything spectacular to write about. According to records sent to me, Obededom Sanders was in the Revolutionary War and I think Ezra was in the Civil War but for the most part they were just ordinary men doing what they needed to do. [Editor's note: this is what I wrote in the April 1997 issue of *Sanders Siftings* about the Walter Sanders mentioned in the letter.]

*I had heard about the big Sanders genealogy collection in the library at Litchfield, Illinois, (mentioned in issue No. 2 of Siftings) but I wanted to see for myself. On a trip to Philadelphia in early March, we made a special stop in Litchfield. The library there (a Carnegie Library built in 1903) is in the middle of a town square. It's a nice building which we first mistook for a courthouse.*

*Walter R. Sanders was a high school teacher in Litchfield who must have spent a lifetime collecting Sanders and Saunders genealogy over most of the Southern and Mid-Western U.S. He used many of his students to record graves in local area cemeteries. Most of his books have a date from the 1960s. He died in February of 1984.*

*I asked to see the Walter Sanders collection and was directed to several shelves. The 14 Sanders/Saunders volumes alone occupied five to six linear feet of shelf space. ■*
